Introduction:

Cold storage plays an important role in the preservation of food before they reach consumers. In this visit participants will be able to take a look at **different types of cold store insulation** including prefabricated panels and insitu sprayed on insulation, advance cold room doors, and different types of industrial refrigeration systems not available in commercial cold stores, including **2-stage liquid overfeed system** incorporating intercoolers, refrigerant pumps, and direct expansion systems employing **economizers**.
