# Technical Seminar on the New Revision of BEAM Plus Existing Buildings (EB) v2.0

BEAM Plus Existing Buildings is a green building rating tool tailor-made for this locality existing buildings. The history of the tools traces back to 1996 when the tool was first known as The Building Environmental Assessment Method (HK-BEAM). With nineteen (19) years' experience, the latest edition of the tool is going to be released on 25 September 2015. This tool will feature enhanced applicability to aged buildings and increased flexibility for adoption. It is expected that the tool will be instrumental to green transformation of Hong Kong existing buildings. The technical seminar shall be presented by Ir CF Leung of Business Environment Council Limited ("BEC"). The content of the seminar includes introduction to BEAM Plus, overview of BEAM Plus EB v2.0 (new assessment frameworks: comprehensive scheme A & B and selective scheme), grading, credits and features of BEAM Plus EB v2.0 and aspect-related topics: management, examples of Energy Use (EU) and Water Use (WU) savings.

CF also delivers BEAM Professional training courses. He is representing BEC in the Board of Directors of BEAM Society Limited.
